Biographical Information:

James (Jim) Martin is a tenured *Professor of Social Work and Social Research* and a *Licensed Independent Clinical Social Worker* with forty-nine years of professional social work practice. His scholarship, teaching, and public service focus on the well being of individuals, families and communities, and his research and civic engagement address military and Veteran populations. A retired *Army Colonel*, Jim's distinguished military career included a wide array of clinical, research, as well as senior program management (command) and policy assignments. Jim was the senior Social Work Officer in the Combat Theater during the First Gulf War.

Jim has served as a subject matter expert for numerous Department of Defense and other related federal, as well as state-level policy, program development, and research initiatives. In 2007 Jim was invited to testify before *The President's Commission on Care for America's Returning Wounded Warriors* and he has remained engaged in initiatives to enhance behavioral health and reintegration services for military/Veteran-connected populations, including services that promote the well being of survivors of military death.

Over his career Jim has brought attention to the duty and military life demands confronting members of our Armed Forces and their families. He has been tireless in his efforts to promote solutions to the many challenges associated with military service and military family life. Jim has demonstrated the ability to conceptualize social problems and apply the resulting knowledge in the development of national, state and local policies and programs that have had positive consequences for military-connected children, families, and communities.

In 2009 Maryland Governor Martin O'Malley appointed Jim to the Maryland's *Veterans Behavioral Health Advisory Committee*. Jim has served as a member of the Maryland *Military Child Education Coalition Steering Committee*; the Council on Social Work Education *Veterans' Mental Health Taskforce*; the National Advisory Board for the *Center for Innovation and Research on Veterans and Military Families* at the University of Southern California; and as a Director on the *American Board of Examiners in Clinical Social Work*. Jim was a founding member of the Board of Directors of the *National Center for Clinical Social Work*.

Jim has a distinguished academic career. In 2009 Jim was awarded the Bryn Mawr College *McPherson Fellowship* for excellence in teaching, research, and service. Jim was the University of Pittsburgh School of Social Work recipient of their 2014 *Distinguished Alumni Award for Social Work Practice* and he received the 2015 *Distinguished Alumni Award* from Boston College's School of Social Work. In 2016 the National Association of Social Workers Foundation recognized Jim as a *Social Work Pioneer*. "Pioneers" are described as "social workers who have explored new territories and built outposts for human services on many frontiers... having made important contributions to the social work profession and to social policies through service, teaching, writing, research, program development, administration, or legislation." During his military career, Jim received multiple awards and decorations including the Legion of Merit, four Meritorious Service Medals, and two Army Commendation Medals. Jim is the recipient of the Army Surgeon General's *Order of Military Medical Merit* and the Surgeon General's "*A*" *Proficiency Designator*—awards recognizing leaders in their specialty who have made significant contributions to the advancement of knowledge in their particular field through extensive publication and active national professional organization membership.

Leadership in Turbulent Times: Reflections From the COVID-19 Experience
